Warranty For Underground Tanks

3000 litre and 5000 litre Rain water 3000 Litre, 4500 Litre, 5000 Litre 6000 Litre Septic Tanks

Subject to the warranty conditions listed below, Global Rotomoulding (the Manufacturer) provides its customers (the purchaser) with the following warranty:

For a period not exceeding 15 years from the purchase date, the Manufacturer will, at its option, repair or replace any defect in the purchaser's underground rain water tank, / or septic tank provided that:

- a) The tank is installed by a certified installer.
- b) Installation instructions are **strictly** complied with as outlined in QF47 3000 Underground tank & QF48 5000 Underground Rain Water tank installation Instructions. QF 152 3000 L and QF 153 4500L, 5000L and 6000L Septic System.
- c) The defect has arisen solely from faulty material or workmanship
- d) The tank has not been subjected to maltreatment or interference.
- e) The fault has not arisen as the result of inattention or installation by the purchaser.
- f) The tank is used solely for the purpose of fixed water storage / Septic System
- g) The tank is not moved from its original installation.
- h) Tank installations MUST comply with local Council requirements.

All implied warranties and conditions other than those provided in the warranty are expressly excluded, except where they cannot be excluded by law. Where such terms cannot be excluded, then to the extent that the law allows, the Manufacturer's liability shall be limited to the remedies available under such legislation and the Manufacturer will not be liable for any special damage, loss of profits, or other indirect or consequential loss or damage suffered by the purchaser.

The purchaser acknowledges that:

- The Manufacturer has the right to modify and improve the design of the purchaser's tank should it be consider necessary; and
- They have read and understood the contents of the warranty.

NOTICE: All purchasers MUST, on receipt of the tank, read and ensure a certified installer is employed to install the tanks as per installation requirements supplied with the tank. If the tank is supplied without installation instructions, please contact Global Rotomoulding and request a copy.

Failure to comply with the Installation requirements will void your warranty.
